On May 8, 2019, at approximately 1800 hours, Detective Kyaw, Detective Zaw, and Officer Casiano (SLU/Certified Spanish Translator) interviewed the complainant at Venezuela Embassy, located at 1099 30 Street, NW.

The complainant reported that last night May 7, 2019, she was assigned to guard the Venezuela Embassy's rear gate. The complainant stated that that she and other demonstrators were guarding the food and water being transported to the Venezuela Embassy by group name "Code Pink". The complainant further stated that "Code Pink" is the activist group that support Venezuelan President and living illegally in the Venezuela Embassy.

The complainant stated that early morning of May 7, 2019, there was a confrontation at the Venezuela Embassy with the group of demonstrators and "Code Pink". The complainant reported that an unknown male from "Code Pink" (hereafter referred to as suspect #1) looked at her and stated "I'm going to get you!"

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:													

The complainant disclosed that May 7, 2019, at approximately 0300 hours, the group of people from "Code Pink" came back to Embassy and attempted to gain entry from the front gate. The complainant reported that during the confrontation at the front gate suspect #1 and an unknown male (hereafter referred to as suspect #2) came to the rear gate.

The complainant reported that suspect #1 looked at the complainant and stated "Oh! It's you again?" and kicked her to the ground. The complainant further reported that when she attempted to get up, suspect #1 placed his hands around her shoulder and kicked her stomach. The complainant stated that while she was on the ground suspect #2 kicked her stomach several times. The complainant stated that she started screaming for help and a group of demonstrators came to rescue.

The complainant stated that one of the demonstrators took the video footage of the suspects with his cell phone. The complainant stated that she got the video footage of the suspects leaving the scene. The undersigned detective reviewed the video footage from the complainant's phone and she positively identified both suspects on the video footage as the people who assaulted her.

The complainant's discharge paper work indicated that x-ray and CT scan did not show any broken bone or internal bleeding. On May 8, 2019, at approximately 1830 hours, Detective Kyaw, Detective Zaw, and Officer Casiano (SLU/Certified Spanish Translator) interviewed W-1.

W-1 stated that on May 7, 2019, at approximately 0300 hours, IT is assigned at the Embassy front gate to stop the group of "Code Pink". W-1 stated that during the confrontation with the group, IT heard someone screaming for help in the rear of the Embassy. W-1 reported that when IT ran back to the rear of the Embassy, IT observed the complainant lying on the ground. W-1 further reported that the both suspects were on top of the complainant, who's screaming for help. W-1 stated that IT was able to rescue the complainant from being assaulted by the suspects, but they mad good escape. W-1 reviewed the video footage from the complainant's cell phone and positively identified the both suspects.

On May 8, 2019, at approximately 1730 hours, Detective Zaw interviewed the United States Secret Service Police Department (USSS) Sgt. Kidd, Trent #S286 and USSS Sgt. Snow, Matt #S228 for additional information. Detective Zaw showed the still image of the suspects picture from the complainant's pone to USSS Sgt. Kidd and USSS Sgt. Snow. USSS Sergeants stated that they were familiar with the suspect #1.

USSS Sgt. Snow further advised that the suspect #1 was involved in a similar incident on 4/30/2019 where he assaulted another female at the Venezuela Embassy. The female did not want to press criminal charges against the suspect #1 and no police reports were filed. A query of MPD databases and Social Media accounts revealed that suspect #1 is the person in the photo that was provided by C-1.

On May 8, 2019, at approximately 2040 hours, USSS Officer B. Cooper B# 1869 observed the suspect #1 comes back to the offense location Venezuela Embassy located at 1099 30 Street, NW. The suspect #1 was stopped in the above listed location and MPD Detectives responded to the scene. The suspect #1 was placed under arrest and transported to the Second District for processing.

On May 27, 2019, at approximately 1200 hours, a photo array was prepared by Detective Kyaw for the view of the complainant. The photo array was shown to the complainant by Detective Zaw at the Second District Police Station. Prior to the showing of the photo array, Detective Zaw read the complainant the instructions on the Photograph Identification Viewing Instruction Sheet (PD 122-A). The photo array consisted of the target and eight fillers. The target was in position number six (6).

The complainant advised that he did not have any questions after the reading of the Photograph Identification Viewing Instructions was read by Detective Zaw. The complainant also affixed her signature on the Photograph Identification Viewing Instructions (PD 122-A) prior to viewing the photo array. The photo array was handed to the complainant and she stated, "The suspect is not in here". The complainant then pointed at #6 and stated "that him, that Max Blumenthal who assaulted me" while tapping at number six (6).
